  may be requested and billed to the vendor. Please contact Jennifer Richards at (828) 320-1314
  with requests.
- 2. Reservations will be made on a first come, first served basis. Regular booking deadline is **January 3, 2025**
- 3. Written notice of cancellation must be received at least 30 days prior to the event in order to receive refund or credit. In the event of late booking, notice of cancellation must be received within 14 days of booking in order to receive credit for charges (no refund).
- 4. Each exhibitor is strongly encouraged to donate at least one door prize, which guests can win and then claim by visiting your booth. Prizes may be present at the show or may be shipped later. Not all guests are licensed locksmiths (required in NC), so we ask that picks and bypass tools etc not be issued as prizes unless proof of licenses are verified.

### **VENDOR SET UP INFORMATION**

Vendors who desire setting up on Friday may do so. Jennifer Richards will be onsite to assist you or answer any questions.

Vendor's may set up anytime Friday the 24th after 2:00 PM

Saturday, Jennifer Richards will be there to let you in beginning at 7:00 a.m. The Trade Show begins at 9:00 a.m.

Vehicles are permitted inside the Hickory Metro Convention Center during show hours for display only. No vehicle will be started or operated during show hours.

Vendors who have vehicle displays need to have them present Friday for setup and inspection.

- Fuel will not exceed one quarter of the tanks capacity or five gallons, whichever is less.
- ♦ All batteries must be disconnected.
- All fuel openings must be locked or sealed.
- Keys will remain with the operation's department while on display.
- Adding or removing fuel on-site is prohibited.
